Appeal and cross-appeals from combined bench and jury trials on matters relating to a boundary dispute. In 23-575, the Hamiltons argue: (1) the Trial Court erred by granting directed verdict on their trespass and royalty-disgorgement claims; (2) the Trial Court abused its discretion on several discovery/evidentiary rulings; (3) the Trial Court erred by finding for the Comptons on their adverse possession claim; (4) denial of prejudgment interest and costs; (5) the jury's verdict on the 1842 boundary should be reversed; and (6) the Trial Court erred by not allowing the individual partners of PBS to be joined as parties.

In 23-577, Shelby Fuel argues that the interpretation of the 1893 deed was improperly submitted to the jury.

In 23-580, Paul Watts also appeals from the trial court's decision to submit the boundary dispute to the jury. He also argues that the Trial Court abused its discretion by allowing the Hamiltons' surveyors to testify, and by allowing the Hamiltons' claim to the Colemans' property to proceed.

In 23-663, PBS and the Thompsons also argue they were entitled to a judgment as a matter of law as to the interpretation of the 1898 deed, the boundary, and ownership of the gas well. They also argue that the Trial Court failed to properly instruct the jury as to the location of the boundary claimed by the Hamiltons.
